Treasurer Report

Summer Camp 2009 Receivables / Refunds. There is an issue with council regarding headcount. Original written "best guess" given to Council was 10 scouts, 2 adult (11 paid participants). Bonnie later gave them a deposit check for 8 scouts and 2 adults (9 paid participants). Bonnie then sent an e-mail to Council with a final headcount of 8 scouts and 2 adults after a string of electronic correspondence between her, Dan Clewley, and Tim Garcia. Rick Mirable reportedly then paid off the "balance due" just prior to camp for 11 participants. Council says Troop 433 owed then payment for 2 more scouts since the headcount was not changed. Council agreed to 50% refund to be given for Freddie Soltero medical cancelation. Bonnie to check with Keatan to see how to get a copy of the canceled check, and forward e-mail sent to Council, cancelled check, and summary of payments broken down by person to Clewley and Garcia to follow-up with Bill Duarte on next best move. Court of Honor (August 25): Review / Suggestions A lot of boys enjoy the pot luck and wish we could have this at each COH. Consensus of attendees was that early start time during school year (5:30 pm vs 6:30 pm) and cost would be an issue. Recommend retaining snacks and punch for Nov/Feb/May CoH. Two parent comments at CoH were that the slide show images were changing too fast (1-3 seconds per slide to get through +/-1200 images in 30 minutes).

New Scouts - Follow up with Michael and Benjamin

Financial Aid – James Munoz with check with the Knights of Columbus regarding availability of funding for scouts dues and uniform.

Troop Trailer - Mr. Garcia no longer able to store troop trailer at his house. Will need new location. Local private storge would add \pm -\$50 per scout for registration fees to cover storage cost. (10'x20' space is \$120 per mo x 12 mo = \$1,400 per year / 30 scouts = \$48 each). James will talk to Roxy

regarding storing in addition to his existing open trailer, Bonnie has a 90" gate and could store in back yard on grass/dirt. Tim Garcia to provide trailer HxWxL dimensions to Bonnie. Would a new concrete patio using Troop funds and Scout labor entice Mr. (Ms.) Garcia to reconsider?

Gift Wrapping: Ella Mirabile offered to confirm locations

Christmas Tree Lot: Sold Mr. Garcia's fathers wood pile, wood is now gone, not available.

Pancake Breakfast: Depends on City funding the West Covina Spring Celebration, KoH does not have a significant drive-by draw as a standalone event, could try to pre-sell breakfast or dinner tickets for event, the low attendance / low interest of the Korean Mass attendees at St. Christopher for pancakes reduced the last breakfast gross income to +/-\$400 and there may be issues getting Church approval.

Popcorn: 9/1/2009 is the due date for pre-order sales (i.e. bulk order upfront for sale door to door sales or in front of stores with product in hand.

February Candy: This was chaired by Ms. Radley with discount candy purchased through her sources, this probably is not be an option.

SCE Lineman's Rodeo: Investigate participation in LA County Fair 2010 booth for recruitment / fund raising options. June 2010 Lineman's Rodeo will probably still be available provided that Bonnie Chiang and/or Tim Garcia continue their employment with SCE.
